Enter the *Student Writing and Media Competition* sponsored by the 1911 Foundation. This competition is designed to promote awareness among the youth in our community of the history of Hutto during the celebration of our 100<sup>th</sup> Birthday. Winning entries will be included in the time capsule with other memorabilia to be unsealed in 2111.

There are four categories in the competition:

***"Why I Love Hutto"*** – an essay of 50 words or less

1. Elementary K-2<sup>nd</sup> grade
2. Elementary 3<sup>rd</sup>-5<sup>th</sup> grade

***"I Am Hutto"*** – a 30-second video clip in DVD format

3. Middle School 6-8<sup>th</sup> grade
4. High School 9-12<sup>th</sup> grade

Prizes awarded in each category as outlined below:

Elementary      1<sup>st</sup> place winners will receive \$50 gift card  
                         2<sup>nd</sup> place winners will receive \$30 gift card  
                         3<sup>rd</sup> place winners will receive \$20 gift card

Middle and High School      1<sup>st</sup> place winners will receive \$100 gift card  
   2<sup>nd</sup> place winners will receive \$75 gift card  
   3<sup>rd</sup> place winners will receive \$50 gift card

Entries must be received by 5 PM CST on June 17, 2011.

Entries may be dropped off at the Hutto Library or Hutto City Hall.

## Official Contest Rules

**Sponsor:** 1911 Foundation

**Eligibility:** Entrant must be currently enrolled and a resident of Hutto ISD. Category for entry is based on grade level for the 2010-2011 school year.

**How and when to enter:** To participate, complete entry form. Deliver completed entry form along with essay or DVD video to either Hutto City Hall, 401 W. Front Street or Hutto Library, 205 West Street on or before 5PM CST June 17, 2011.

Essays or DVD videos received after the deadline will result in disqualification of entrant. All entries remain property of the sponsor and will not be returned.

Only one entry per person.

Sponsor is not responsible for lost, stolen, late, illegible, incomplete, damaged, mutilated, misdirected, altered or tampered with materials. Sponsor not responsible for technical failures of any kind. Videos exceeding 30 seconds will be judged on the first 30-second segment only.

**How and when selected and notified:** Entries will be judged by a committee who will score each entry based on creativity, content, presentation and relevance. Winners will be notified by phone/mail after all entries have been judged, but no later than July 1, 2011. Winners are expected to present their essays and videos during the opening Centennial festivities to be held on Friday, July 15, 2011, at which time they will also receive their prizes.

By participating, entrants give permission to the sponsor to publish entrants name, grade and content of essay or DVD video. By participating, entrants agree to be bound by these official rules and decisions of sponsor that shall be final in all respects.
